- All bank charges are to be borne by the delegates.

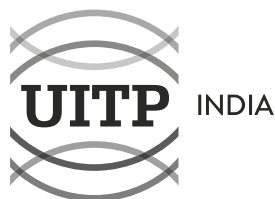
