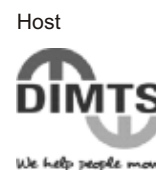
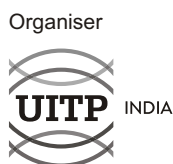

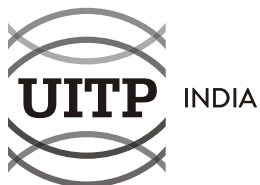
Terms and Conditions
